Education Queensland uses comprehensive control systems for all computers accessing the Internet, including those at Sherwood State School. In this context, I understand that:

- access to computers, software and the Internet provides students with supportive learning experiences and is used regularly as part of the school's learning program;
- that the school cannot control exclusively what is on those computers once logged onto the internet;
- that a very small part of that information may be illegal, dangerous or offensive.

I accept that, while teachers and staff will always exercise their duty of care, protection against exposure to harmful information on the internet would depend ultimately upon the responsible use by students as outlined in the **Acceptable User Guidelines**. ## Sherwood SS ICT Acceptable User Guidelines

### ***Belief Statement:***

ICT equipment and resources are for everyone to use. At Sherwood SS staff will teach all students to use these resources in a positive and productive manner. The school encourages acceptable uses of ICTs that support curriculum in a variety of locations both in and out of the classroom.

### ***Guidelines:***

Students will receive instruction in the responsible use of the school's ICT resources by reading this document and through instruction from their teachers about acceptable uses of ICTs.

Students are **responsible for their actions** while using ICT resources in the school. They will be disciplined if they use ICTs in a way that is unacceptable.

### ***Student Expectations:***

- **Always use appropriate behavior** when using school ICT resources. The use of offensive language, sending or viewing unacceptable or adult materials are strictly forbidden.
- **Never send offensive email, sms/text messages** to another person or within other electronic "chat room" style locations (Yr P-6).
- **Notify an adult immediately** if you see things on the computer that you feel are bad, inappropriate and / or illegal.
- **All information obtained from the internet is protected by copyright.** You should write down all your sources of information and images used in study.
- **Student folders are private property.** Only enter a folder if it is yours. If a computer has not been logged off please let your teacher know before starting your work.
- If you wish to ensure your privacy, **do not share your passwords** with anyone.
- Revealing on the internet your home address, telephone number or last name, or those of your fellow students, is dangerous, and **must be avoided.**
- To conserve, or not waste paper and toner, **only print materials** that are relevant to your assigned class work. The school reserves the right to determine what is and is not relevant. Thank you for checking with your teacher first.
- Do not engage in any activities that will **hurt school equipment** or network systems.
- Having food or drinks in the Library or near classroom computers is **not permitted.**
- The use of storage devices to transfer work from home and school, such as discs, CDs, DVDs and Removable HDs (smart media), are the **responsibility of their owner** to use correctly and manage.
