Why iPads?

We adopted a Bring Your Own Device (BYOD) program in 2020 to ensure students are best prepared for their future by working with staff to embed strong ICT pedagogy in all classrooms. This concept has evolved and below are the three device options which you will find in our Year 2 - 5 classrooms, to ensure equity and choice for parents.

Each year when we form our classes we ensure they are well-balanced, taking into consideration the unique needs of all students, their wellbeing, and academic requirements. As each child at Sherwood will have access to a device through one of these options, we no longer factor the ratio of device usage into class formation.



School Provided Technology (SPT) Classrooms will have 'pods' of iPads to support students where families choose not to opt in. iPads remain at school 1:2 ratio



Hire program Families can hire a school device to allow financial equity 1:1 ratio during school time, with devices remaining at school

The Department of Education recommends Apple iPads as the safest device for use within our schools. It is important to remember the iPad is *just one tool* in our 21st century classrooms like any workbook, pencil, or whiteboard. They are portable, flexible, and have the ability to encourage and extend student engagement through goal-directed learning, and by creating student agency in how work is completed. Our aim is for iPads to encourage real-time feedback during class time and allow students to proudly and regularly share completed work with parents at home.

In addition, the move to online NAPLAN testing is best supported by ongoing digital awareness and reinforcement. However, please remember the most important factor linked to positive outcomes for your child at school is their teacher. Our teachers and their pedagogy is what makes learning so powerful and ensuring that our staff have every opportunity to enhance their pedagogy has always been our number one focus.

BYOD specifications

To keep pace with changes in technology and teaching and learning, the below list outlines the minimum requirements for a device to be effectively used at school. We believe in most circumstances, aside from annual app purchases, an iPad will last a student four years, taking them through Years 2 - 5 without further investment. Ipads allow for all students to access the curriculum. They create personalised learning for students to keep them engaged and allow them to demonstrate what they know and can do - classroom teacher

Please note, iPad Minis or android devices are not suitable for use. An Apple Store "apps" list will be made available for all year levels, and all families will require an Apple account to purchase these.

We have two purchasing support options, offering a special price for Sherwood students. Please note, these are suggestions only, and you may purchase your device through whichever supplier suits you best.

32 GB or higher

Wi-Fi model (no cellular enabled devices)
