# Footsteps Dance Program (Prep-Y6)

Dear Parents and Carers

In Term 3, our school will be participating in a 10 week dance program with Footsteps **commencing Wednesday 15<sup>th</sup> July 2020.** 

The course will introduce students to a basic proficiency in a number of dance styles including hip-hop, contemporary, ballroom and modern. During the program, students learn to dance both individually and with a partner, promoting social interaction, confidence building and improving fitness levels. As this program is linked to the Arts curriculum and assessment and reporting for the semester, participation by all students is optimal. Footsteps instructors are experienced dance teachers. No previous dance experience or skills are required to part take in the program and students will get to perform their year level dances with the Footsteps instructors at our Term 3 disco.

**When:** Week 1 to 10 in Term 3. Prep – Year 5 lessons will be on Wednesdays. Year 6 lessons will be on Fridays. Please note: Year 6 students will have their Ekka Public Holiday make up lesson on Friday Week 10 of Term 2.

Activity Costs: The cost of the 10 week dance course is \$20 per student. You will receive an invoice by email for this activity which you may pay via the following methods:-
